

“Apply & Get Complimentary Gift + Extra 3% Cashback with Campu Bank Visa Business Credit Card” Promotion

Terms and Conditions

Promotion Period

1. The Promotion is valid from 1 February 2026 to 30 June 2026, while the budget and the gift stocks last (both dates are inclusive).

Eligibility

2. The promotion is open exclusively to new and existing Campu Bank Visa Business Credit Cardmembers hereinafter referred to as “Eligible Cardmembers”.

Apply & Get Complimentary Gift

3. New eligible cardmembers will be entitled to a Complimentary Gift based on the following criteria:

As the Bank's makes no representation or warranty to the quality, merchantability or suitability for use of the Complimentary Gift and accordingly the Bank shall not be responsible to replace any lost, stolen or defective Complimentary Gift due to defects in material or workmanship by manufacturer under warranty or otherwise. The eligible cardmember is to liaise / contact the manufacturer directly and/or its authorised dealer for such warranty information, claim and/or terms conditions specific to the installation, specification, usage and/or operation of the Complimentary Gift.

Get Extra 3% Cashback

11. New and existing eligible cardmembers will be entitled to extra 3% cashback based on the following criteria hereinafter referred to as "Eligible Transactions":
 - ✓ Minimum spend of USD10 per transaction.
 - ✓ Maximum cashback of USD30 per month.
 - ✓ "Qualified Transactions" shall include the overseas ONLINE purchase of goods or services with the use of the Campu Bank Visa Business Credit Card.
 - ✓ The tracking of Qualified Transactions shall be based on transaction date.
 - ✓ Total cashback pay-out is capped at USD10,000 on 'first come, first serve' basis.
 - ✓ The cashback payment will be instantly credited into eligible cardmember's card account and upon fulfilment of all terms and conditions as stated above.
 - ✓ In the event that there is a reversal of entry made on the spending due to whatsoever reason after the cashback is credited into the eligible cardmember's card account, cardmember is required to refund to the Bank for the entire cashback payment that is credited into the account.
