

“Campu Bank Cashback Program XVI” Promotion

Terms and Conditions

1. The “0.30% for Cashback Rewards with Campu Bank Platinum Card” Promotion is valid for a period of 1 year from 1 January 2024 to 31 December 2024 (both dates are inclusive) (Promotion Period)
2. The Promotion is only open exclusively for both existing and new Campu Bank Platinum Credit and Debit Cardmembers including Campu Bank Group staff hereinafter referred to as “Eligible Cardmembers”.
3. During the promotional period, the qualified Cardmembers will be entitled to receive the Cashback Rewards when they use any Campu Bank Platinum Card.
4. The Qualified Retail Transactions shall include all local and overseas retail spending, online purchases and full purchase amount under the Zero Interest Installment Plan (ZIIP) excluding cash advance or cash withdrawals.
5. The Cashback rewards will be calculated based on a single tier rate of 0.30% for Platinum Cards regardless of any amount and based on the retail spending amount during the Promotional Period.
6. The tracking of Qualifying Retail Transactions shall be based on transaction date, the computation of the Cashback Rewards is as follows:

7. Qualified Retail Purchases made by a Supplementary Cardmember shall be also eligible for Cashback.
8. The Cashback payment will be instantly credited to eligible cardmember’ Platinum credit card account and credited into eligible Platinum debit cardmember’s deposit account linked to the card on the next working day after the transaction was settled by the merchant.
9. The Qualified Cardmember’s account must be current, valid and in good standing to be eligible for the Cashback Rewards.
10. The Cashback is non-transferable to any 3rd party and non-exchangeable for up-front cash or any other benefits in kinds.
11. In the event that after the Cashback Rewards are credited into the Qualified Cardmember’s Platinum Card account and there is a reversal of entry made on any one of the Qualifying Retail Transactions, the Qualified Cardmember is required to reimburse the Bank for the entire Cashback Rewards credited into his/her account.

General Terms and Conditions

1. The Bank reserves the right to change, amend, delete or add on to these Terms and Conditions from time to time with at least twenty one (21) calendar days prior notice which notice of such change, amendment, deletion or addition shall be published on the Bank's website www.cpbefbank.com.
2. By participating in the Campaign, the Eligible Cardmembers shall be deemed to have read, understood and agreed to be bound by the Terms and Conditions as stated herein. The decision of the Bank shall be final, binding and conclusive. No correspondence, disputes and appeals will be entertained.
3. The Bank reserves the right to cancel, terminate or suspend the Promotion. For the avoidance of doubt, cancellation, termination or suspension by the Bank of the Promotion shall not entitle the Eligible Cardmember to any claim or compensation against the Bank for any and all loss or damage suffered or incurred by the Eligible Cardmember as a direct and indirect result of the act of cancellation, termination or suspension.
4. The Bank shall not be liable, whether direct or consequential, for any loss and damage or whatsoever suffered by the Eligible Cardmembers, caused directly or indirectly, in whole or in part, from their participation in the Campaign as a result of any act or omission on the part of the Bank.
5. The Terms and Conditions herein are in addition to and without prejudice to the Terms and Conditions stated in the Cardmember Agreement applicable to the Eligible Cardmembers' Cards. In the event of any inconsistency between these Terms and Conditions and the said Agreement, these Terms and Conditions shall prevail in so far as they apply to the "Campu Bank Cashback Program XVI" Promotion.
